he was fun & lighthearted

I was very comfortable w/ him

felt blessed & safe

1st visit he called me in to do massage

I froze didn't know how to react

felt very vulnerable

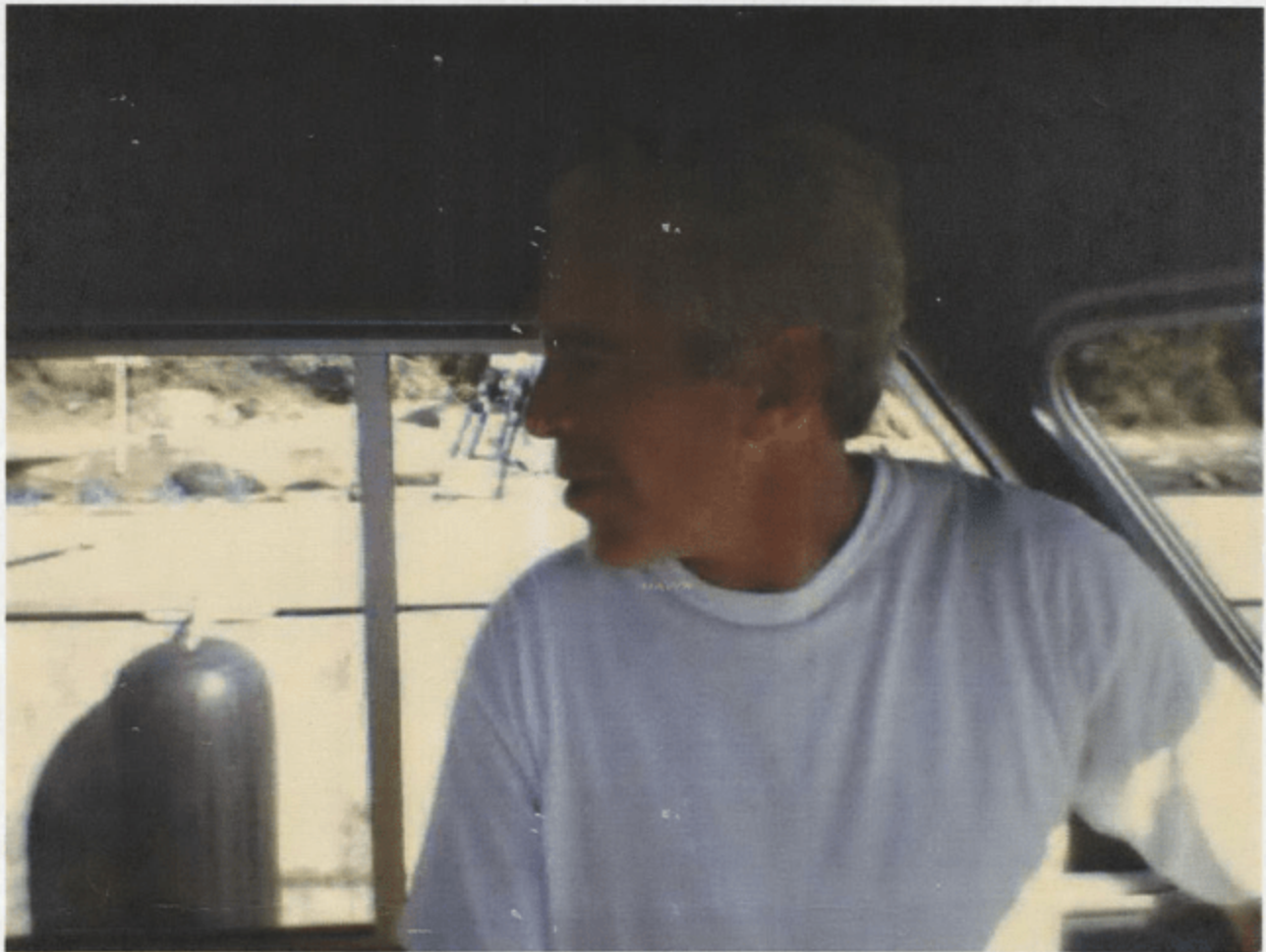
